Jennifer moved to approve Consent Agenda; 2nd Brad. Unanimous approval.

Business Items:

Ad Hoc Committee Charge for Security/Risk Mitigation and Fire/Disaster Safety - follow-up. Rev. Nori noted the availability of grants from the Dept. of Homeland Security for initiatives to protect faith communities from terrorist activity.

Policy for Staff Pay Dates.

The current Finance policy re staff pay dates states that employees will be paid monthly on the first day of the month. Brad suggested the preferred date for pay payment be the last business day of the month. A motion was made to adopt the last business day of the month as the staff pay date. Jennifer seconded the motion. Unanimous approval.

Graham Kreicker shared a number of comments:Burning of brush piles on the property.Paint on transom windows in Founder Hall will be removed.High pile of chairs will be shortened in lobby welcome area.Sanctuary side aisles need to be maintained with four-foot wide clearance.

Bill Hagle's comments:

Discussion of what to do about the large swing set in the play yard that has currently been dismantled. Swing sets that large are considered a safety hazard. Jennifer made a motion to not have the swing set materials reassembled for use; Brad seconded motion. Unanimous approval.

Danger of tree branches over-hanging sanctuary. Consensus for the need to obtain a written quote for tree removal. Graham will discuss matter with Mary Holm. An email Board vote on expenditure is a possibility.

Mary Holm recommended that a picture rail be installed in the lobby.

Decision is needed on how to handle the lichen on sanctuary building siding. Oct 19th decision will be made.
